CIRCULAR NO.: 07/2015 MEDICAL SCHEME ACCREDITATION

ACCREDITED SCHEMES FOR 2016

The medical schemes, which have been <u>unconditionally</u> accredited by the Executive Committee of the Central Council for the 2016 year, are:

- 1. SAMWUMED
- 2. KEY HEALTH
- 3. BONITAS
- 4. LA HEALTH

In respect of HOSMED, the Executive Committee has conditionally accredited HOSMED as follows:

"9.1.2 Hosmed Medical Scheme is accredited conditionally with the proviso that it ensures that a properly elected Board of Trustees is in place by 30 September 2015, as indicated in its application form. In the event that Hosmed fails and/or neglects to elect a Board of Trustees, as undertaken in its application form, its accreditation shall be withdrawn."

The Council wishes to advise employees and employers that HOSMED had undertaken in its application to elect its Board of Trustees by the 30 September 2015. Members belonging to HOSMED should direct any queries relating to this issue to HOSMED.

MARKETING PERIOD FOR ACCREDITED MEDICAL SCHEMES

The accredited medical schemes, for the 2016 period, may market their schemes from 1 October 2015 to 30 November 2015. All municipalities must ensure that every accredited scheme is given equitable time to market their products to the employees in the municipality.
